New Policies

The spring CDPEI Council approved four new policies including:

- Registration Renewal Policy
- Late fee & Forfeiture of License Policy
- Resignation Policy
- Registration through Labour Mobility

These policies outline the renewal process, guidelines for late fees, license forfeiture, transfer of licenses, and resignation for renewals moving forward. As per the Resignation Policy, <u>it is now a requirement for members to contact the registrar/deputy registrar to resign if not renewing their membership.</u> The policies are available on the members section of the CDPEI website.
