Private Practice RD list on website

CDPEI is in the process of compiling a list of Private Practice Registered Dietitians (PPRDs) to be featured on our website. The goal is to improve public access to registered dietitian services while enhancing safety and providing clear contact information for individuals seeking nutrition services. Council Member Opportunity

The College of Dietitians of Prince Edward Island is putting out a call for a new volunteer Council member. The College is currently looking for one new registrant to serve on the Council. The time commitment for a CDPEI Council member is typically 3 to 4 hours per month dependent on the position you hold. The Council meets 6 to 8 times per year. The meetings are held virtually and typically 2 hours in duration. The Council is supported by two part-time staff members. Website Sub-Committee Update

The Website Sub-Committee has been dissolved, and the implementation of the Sub-Committee's recommendations is currently underway, including (1) a trial of electronic renewal and registration, (2) improvements to the existing website, and (3) the inclusion of a Private Practice RD directory. The Sub-Committee raised concerns over the significant increase in quotes for alternative website options, which exceeded initial cost estimates, leading to worries about the potential financial impact on registrants.

The Sub-Committee may reconvene if the Council decides to explore alternative website options or conducts a survey to assess registrant interest in an updated website versus a potential fee increase. The Sub-Committee's work has laid a solid foundation for future website evaluations, highlighting the importance of member feedback and sound financial planning. Further details will be provided in the 2025 annual report.

Continuing Education (CE) Audits

CDPEI audits 20% of CE submissions annually. Registrants will only receive their CE point tally if selected for an audit. To ensure compliance, we recommend keeping all relevant documents—such as certificates and learning details—for at least three years in case additional information is required. As we do not tally points for all registrants each year, we encourage registrants to track CE points to help determine whether additional continuing education is needed.
